

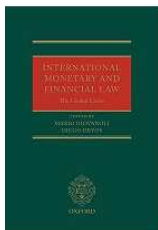

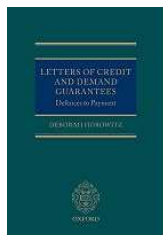

This book is the first to provide an extensive analysis of the range of defences to payment under letters of credit and demand guarantees. It considers the extent to which different defences undermine the abstraction of these instruments. This is a fundamental issue, since letters of credit and demand guarantees are designed to be abstract, or autonomous, from the underlying contract that called for their use. The purpose of that abstraction is to provide certainty of payment, but the various defences diminish that certainty. The book examines the spectrum of defences that are frequently litigated and debated in international practice: fraud in the documents, nullity, fraud affecting deferred payment letters of credit, fraud as no honest belief, unconscionable conduct and illegality. Vitally, the book provides analysis of the relevant judicial decisions and offers clear practical guidance on which defences are most suitable for each instrument.

The idea of 'post-industrial society' and a constellation of related terms, such as 'service society', 'knowledge society' and 'information society', achieved a prominent place in debates in sociology from the 1970s as analysts sought to make sense of the ways in which modern forms of life were being transformed. The central thesis, outlined in the influential works of American sociologist Daniel Bell, is that economic life, production and the world of work have been transformed by the introduction of innovations in information technology. In particular, in the second half of the 20th century in the more highly developed societies, employment in manufacturing declined and professional, technical and other service occupations increased in number as developments in theoretical knowledge, information technology and communications became the initiators of change
